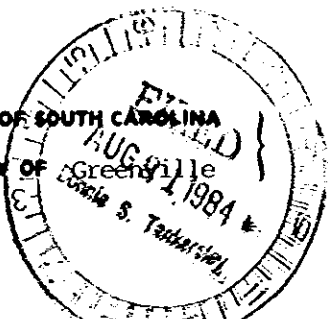

(hereinafter referred to as Mortgagor) is well and truly indebted unto Finance South, Inc.

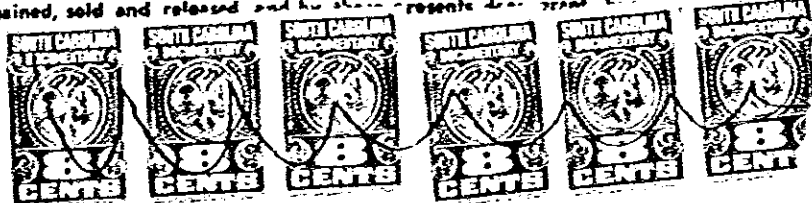
