 - Section 3 Delete in line 16 the phrase "and shall properly adjust any payments which shall have been made under (a) of paragraph 2.".
- Paragraph 9 is incorporated herein except that it also shall include the 4. following additional provision: This option may not be exercised by the mortgagee when the ineligibility for insurance under the National Housing Act is due to the mortgagee's failure to remit the mortgage insurance premium to the Department of Housing and Urban Development.
