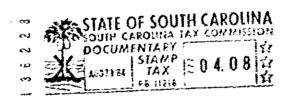
MORTGAGE

TO SECURE to Lender the repayment of the indebtedness evidenced by the Note, with interest thereon; the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage; and the performance of the covenants and agreements of Borrower herein contained, Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville...., State of South Carolina:

ALL that piece, parcel or lot of land, with all improvements thereon, in the State of South Carolina, County of Greenville, being shown as 1.5 acres, more or less, on a plat of Property of Frances Cox Greene, dated May 10, 1971, and prepared by T. H. Walker, Jr., RLS, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Brown Drive, at joint front corner with property now or formerly of Cecil Jones Maxwell and running thence with the Maxwell line, S. 79-32 W. 401.3 feet to a stone at the joint corner with property now or formerly of Carolina, Inc.; thence with the line of Carolina, Inc., N. 1-47 W. 163.0 feet to an iron pin at joint corner with property now or formerly of Wade D. Brown, Jr. and D nnelle C. Brown; thence with the Brown line, N. 79-16 E. 364.5 feet to a nail and cap in center of Brown Drive; thence with the center of Brown Drive, N. 14-00 W. 173.0 feet to an old iron pin, being the point of beginning.

This being the identical property conveyed to the Mortgagor herein by deed of Paul Ted Greene, Sr., recorded October 12, 1973, in the RMC Office for Greenville County in Deed Book 986 at Page 66.



TO HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances and rents, all of which shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are hereinafter referred to as the "Property."

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, and that the Property is unencumbered, except for encumbrances of record. Borrower covenants that Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to encumbrances of record.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal and interest indebtedness evidenced by the Note and late charges as provided in the Note.

2. Funds for Taxes and Insurance. Subject to applicable law or a written waiver by Lender. Borrower shall pay to Lender on the day monthly payments of principal and interest are payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments (including condominium and
