The Mortgagor further coverants and agrees as follows

- (1) That this mortgage shall secure the Mortgagee for such further saids as may be a virtical recenter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the convenants herein. (8) That the covenants herein contained shall bird, and the benefits and advantages shall inure to the respective heirs, executors, administrators, successors and assigns, of the parties herety. Whenever used the singular shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
