Maximum and Minimum Interest Rate Nothwithstanding anything to the contrary contained in the Mortgage and Note, the rate at which interest shall accrue under the Note shall not be changed upward or downward by more than \_\_\_\_ on any Change Date, and shall not be changed upward or downward by more than 5.125% over the life of the loan.
- 2. Effectiveness of Provisions Except as otherwise provided in this Rider, all of the provisions of the Mortgage and Note shall remain in full force and effect.
