SSMENTS, CHARGES Mortgagor shall pay all taxes assessments and the Property within thirty (30) days after the same shall become due. In the event that Mortgagor fails to pay all taxes assessments and charges as herein required, thep Morigage, at its option, may pay the same and the amounts paid shall be added to the Contract secured by this Mortgage, and shall be due and payable by Mortgagor to Mortgagee upon demand of Mortgagee 4. ACCELERATION: REMEDIES. All rents collected by the receiver shall be applied first to payment of the costs of the management of the Property and collection of rents, including, but not limited to receiver's fees, premiums on receiver's bonds and reasonable attorney's fees, and then to the sums secured by this Mortgage. The receiver shall be liable to account only for those rents actually received. 11. ASSIGNMENT. This Mortgage may be assigned by the Mortgagee without consent of the Mortgagor.
