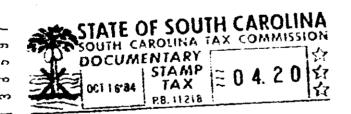

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 45 on plat of Wynette Estates of Pickell and Pickell, Engrs., dated July 24, 1953, and recorded in the RMC office for Greenville County, South Carolina in Plat Book EE, Page 37 and having according to said plat, the following metes and bounds:
