ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Traction Street, being shown and designated asLot No. 328 on a plat entitled "Section No. 2, Abney Mills, Brandon Plant", recorded in the RMC Office for Greenville County, S. C. in Plat Book QQ at Page 59, and being further shown on a more recent plat by Freeland & Associates, dated October 10, 1984, entitled "Property of William R. Lasley, Jr.", recorded in the RMC Office for Greenville County in Plat Book | C at Page | C and having, according to said latter plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Traction Street at the joint front corner of Lots Nos. 328 and 329, and running thence along the common line of said lots, S. 43-53 W. 119.99 feet to an iron pin; thence N. 45-54 W. 75.25 feet to an iron pin at the joint rear corner of Lots Nos. 327 and 328; thence running along the common line of said lots, N. 44-00 E. 119.85 feet to an iron pin on the southern side of Traction Street; thence along said Traction Street, S. 46-01 E. 75.00 feet to an iron pin, the point of beginning.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:
