ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, lying on the Southwestern side of Verner Drive and being known and designated as Lot #20 of Cedar Vale Subdivision, according to a plat prepared by Robert R.
