ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that certain piece, parcel or lot of land on the northeast side of Edgewood Avenue, in Greenville Township, Greenville County, South Carolina, near the City of Greenville, being shown as Lot No. 31 on Plat of Leawood, made by Dalton and Neves, Engineers, June 1949, recorded in the R.M.C. Office for Greenville County in Plat Book "J", pages 18 and 19, and having according to said plat, the following metes and bounds to wit:
