To All Whom These Presents May Concern: I, Josephine B. McMurray  
SEND GREETING:

Whereas, I, the said Josephine B. McMurray  
in and by my certain promissory note in writing, of even date with these  
Presents, am well and truly indebted to The Dixie Fire and Casualty Company, Greer,  
South Carolina  
in the full and just sum of Nine Thousand and no/100 (\$9,000.00) Dollars  
to be paid in monthly instalments of Fifty-nine and 40/100 (\$59.40) Dollars each until the entire principal and interest be paid in full,  
said payments to be first applied to interest with balance to principal, the first  
payment being due March 1, 1973.

Interest thereon from date hereof 1973  
at the rate of five per centum per annum, to be computed and paid monthly in said instalments  
until paid in full; all interest not paid when due to bear  
interest at same rate as principal, and if any portion of principal or interest be at any time past due and unpaid,
