County of Greenville, State of South Carolina, near the western limits  
of the Town of Greer, on the west side of North Street, and shown as  
lot # 19 on the plat of the T.E. Armstrong property, prepared by H.S.  
Brockman, Surveyor, October 7th 1943 and having the following courses  
and distances, to-wit:-

BEGINNING at joint corner of lots 20-19 on west side of North Street  
and runs thence with said street, N 6-15 E forty nine (49) feet to  
iron pin, cornering with the Westview property; thence N 74-00 W One  
hundred Eighty four feet (184) to pin on the Groce line in or near  
branch; thence with the Groce line S 2-00 W Forty eight and seven-tenths
