NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns,

"All that certain piece, part or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, on the northern side of John Street, in the City of Greenville and described as follows:

BEGINNING at an iron pin at the intersection of John Street, and a 14 foot alley, 184.3 feet from Butler Avenue, and running thence with John Street, N. 64-54 W. 50 feet to an iron pin at corner of John Street School property; thence with line of that property N. 21 E. 123.3 feet to an iron pin on a 16 foot alley; thence with line of saiddalley, S. 57-33 E. 52 feet to an iron pin; thence with in a southwesterly direction 120 feet to the beginning corner.
