WHEREAS, the said Mortgagor(s) is and be it is certain promissory note in writing, of even date with these Presents, is well and truly indebted to N. Morris Barton - - -

to be paid as follows: In forty-eight (48) equal installments of \$64.43, the first payment to become due on April 15, 1970, with subsequent payments due on the 15th day of each month thereafter,

with interest thereon from - - - at the rate of - - - per centum per annum to be computed and paid - - -

until paid in full, all interest to paid when due to be paid interest at the same rate so principal and if any portion of principal or interest thereon is late due and unpaid, the same will be added to the said note to become immediately due, at the option of the Lender, who may do there shall be no charge and in case said note should be placed in the hands of a lawyer for suit or claim against the Mortgagor(s) to pay all costs and expenses including reasonable attorney's fees, shall be liable to the mortgagee in damages and to be secured under this instrument in a sum of \$1,000.00.

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagor according to the terms of the said note, and also in consideration of the further sum of Four Dollars (\$4.00) and 00 cents, paid by the said Mortgagor(s) and before the signing of this Agreement, in payment of taxes acknowledged have granted, bargained and sold and by these presents do give, grant and convey all undivided undivided title to the said Mortgagor, N. Morris Barton, or his heirs and assigns forever:

All that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina, being a portion of land formerly owned by J. W. Ballenger, located about five (5) miles North of Greenville, known and designated as tract No. 1, as shown on plan of property of Floyd Cutt and T. S. Bruce prepared by J. W. Bruce, R. S., said plan being recorded in the R. W. C. Office for Greenville County in Plat Book 17 at Page 1, and before more particularly described as follows:

BEGINNING at a nail in intersection of a County Road and a new cut road, said running thence down the new cut road, N. 44-30 E. 175 feet to an iron pin three along the line of tract No. 15, N. 44-30 E. 175 feet to an iron pin corner of tract No. 2, S. 87-00 E. 760 feet to an iron pin on bank of County Road; thence down the center of County Road, N. 85-53 E. 100 feet to a nail in the center of said County Road; thence S. 54-55 E. 250 feet to the point of beginning, containing 5.6 acres, more or less.
