WHEREAS, we, Ralph C. Jones and Bartore/^{Ann} Jones

(hereinafter referred to as Mortgagor) is well and truly indebted unto Sarah V. Brain

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, to the sum of **seventy-eight hundred dollars**

as follows: \$500.00 to be due on or before 60 days from date, and the balance of \$7,500.00 to be paid at the rate of \$50.00 per month hereafter until paid in full, payments to be applied first to interest and the balance to principal, the first payment to be due December 5, 1966, and the remaining payments to be due on the fifth day of each and every month thereafter until paid in full, with the right to anticipate payment in full with interest thereon from date at the rate of **six per cent per annum to be paid monthly** or in part at any time.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose.

KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee, agrees with the Mortgagor, and also in consideration of the further sum of **one thousand (\$1,000.00)** to be paid by him when he shall well and truly discharge all arrearages of and before the making and delivery of these presents, the receipt whereof is hereby acknowledged, his grantee, bargained, sold and released, and by these presents does, grant, assign, sell and release unto the Mortgagee, his successors and assigns,

all the aforesaid property, parcels of land, with all improvements thereon, heretofore constructed thereon, situated, lying and being in the State of South Carolina, County of Greenville, and Franklin Township, on **Dobbin Road and Loker Road**, and being specifically described as follows:

Beginning at a point at the intersection of said Dobbin Road and Loker Road, and running eastwardly along said Loker Road to an iron pin in the center of said old road bed; thence N. 3-30 W. 100 feet to an iron pin; thence S. 73-15 E. 40.1 feet to a point in the back of roads; thence with said Dobbin Road, S. 15 E. 146 feet to a point in said road; thence driving said road, N. 36-30 W. 101.3 feet to an iron ring; thence S. 13-30 W. 110 feet to an iron pin; thence N. 3-30 W. 100 feet to an iron pin; thence S. 36-30 W. 400 feet to an iron pin on the western edge of Dobbin Road; thence with said road facing N. S. 1-30 W. 100 feet to a point in said road; thence S. 5-30 E. 400 feet to the point of beginning.
