truly bound by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has
fully paid by the Mortgagor at and before the sealing and delivery of these presents the sum of one thousand dollars (\$ 1,000),
and assigned, bargained, sold and released, and to these presents does grant, bargain, sell and release unto the Mortgagor, its successors
and assigns:

All, that certain place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being
in the State of South Carolina, County of Greenville, to wit:

All, that certain place, parcel or lot of land, together with the improvements thereon,
situate, lying and being on the northwestern side of Lynching Drive, in the county of
Greenville, State of South Carolina, being known and designated as lot No. 27 of Section
One on plan of Richard's Mills filed in the R.M.C. Office for Greenville County in Plat
book 334, Page 31 and Survey, according to said plat, the following metes and bounds,
to wit:

Beginning at an iron pin on the northwestern side of Lynching Drive at the joint front
corners of Lots Nos. 26 and 27, and running thence N. W-45 E. 150 Feet to an iron pin;
thence N. 25-15 E. 100 Feet to an iron pin at the corner of Lot No. 28; thence S. 30-15 E.
150 Feet to an iron pin on the northwestern side of Lynching Drive; thence with said
corner to the point of beginning.
