A certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 9.55 acres, more or less, being known and designated as Property of Woodrow Watson according to a plat dated June 18, 1968 by C. O. Riddle, and having the following metes and bounds, to-wit:

BEGINNING at a point in the center of Griffith Road, the joint front corner of property now or formerly of Della S. Watson and property described below, and running thence S. 43-36 E., 910.6 feet to a point in the center of the branch; thence with the branch as the line, S. 43-30 W. 441.7 feet to a point in the center of said branch; thence N. 45-50 W., 912 feet to a point in the center of Griffith Road; thence with the center of said Griffith Road, N. 43-23 E. 485 feet to the point of beginning.
