1971-1972 MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

THIS MORTGAGE SECURES THE ADVANCES - MAXIMUM OUTSTANDING \$10,000.

WHEREAS, James B. and Mildred Hayes,

hereinafter referred to as Mortgagor, is well and truly indebted unto MCC Financial Services,

its successors and assigns (hereinafter referred to as Mortgagee) evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of \$10,000.00.

\$10,000.00, Second due, and \$0.00 interest, Dollars 13, \$13,20, 1 due and payable

a monthly installment of \$ 111.67, the first installment becoming due and payable on the 20th day of May, 1971,

and a like installment becoming due and payable on the same day of each successive month thereafter until the entire indebtedness has been paid, with interest thereon from maturity at the rate of seven per centum per annum, to be paid on demand. PAID AND SATISFIED IN FULL THIS 23rd JULY 1971

WHEREAS, the Mortgagor has hereafter become indebted to the said Mortgagor for 100% of the amount advanced July 1971 for taxes, insurance premiums, public assessments, repairs, or for any other purpose.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid note and interest, does hereby grant, convey and deliver to the Mortgagee, the sum and other obligations for which the Mortgagor may be indebted to the Mortgagee at any time, a fee simple estate in the following described land:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being in the State of South Carolina, County of Greenville, to-wit:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situated, lying and being near the city of Greenville, County of Greenville, S.C., being known and designated as Lot # 82, on Map of Riverdale, which plat is recorded in the RC Office for Greenville County, S.C. in Plat Book 11, page 107 and having, according to said plat, the following lines and bounds to-wit:

Beginning at an iron pin on southerly side of New View Drive, joint front corner of lots 12 & 83, and running thence S. 3-11 E. 230 feet to an iron pin; thence S. 66-18 W. 15 feet to an iron pin; thence N. 14-45 E. 217.2 feet to an iron pin on Knollview Drive; thence along Knollview Drive S. N-44 E. 97.1 feet to an iron pin, the point of beginning.

This is the same lot conveyed by grantor by C.B. Robinson, Jr. Trustee by deed recorded June 23, 1971 in deed vol. 116 page 152 of the RC Office for Greenville County, S.C. and is conveyed subject to restrictions applicable to said subdivision in vol. 552 page 53, and to any recorded easements or rights of way or leases shown on the title as of the record.
