by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid to the
Mortgagee at and before the signing and delivery of these presents, the receipt whereof is herein acknowledged, has granted, bargained, sold
and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,

ALL that certain piece, parcel or lot of land, with all improvements thereon, or heretofore constructed thereon, situated, lying and being
in the State of South Carolina, County of Greenville, in Greenville Township, being known
and designated as Lot No. 4, Block E. of the C.P. WILLIS Property as shown
on plat recorded in Plat Book "T", at Page 176, and more particularly
described according to said plat as follows:

BEGINNING at an iron pin on the northern side of Prentiss Avenue, corner
Lot 4, which point is 132 feet from the corner of Elm Street and Prentiss
Avenue and running thence along the northern side of Prentiss Avenue,
S. 45-27 W. 66 feet to an iron pin, corner of Lot No. 5; thence with
