"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 79, as shown on plat of Holly Tree Plantation recorded in plat book 4 X page 37 of the RMC Office for Greenville County, S. C. and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Mornington Court the joint front corner of Lots 79 & 80 and running thence with the joint line of said lots N. 16-12 W. 179.11 feet to an iron pin, the joint rear corner of Lots 79 & 80; thence with the rear line of lot No. 79 N. 30° -50'-22" E. 66.87 feet to an iron pin the joint rear corner of Lots 78 & 79; thence with the joint line of said lots S. 62-39 E. 227.60 feet to an iron pin on the northern side of Mornington Court; thence with the northern side of said Court S. 410-50'-11" W. 19.28 feet to an iron pin; thence S. 80-48 W. 44.24 feet to an iron pin; thence S. 44-02 W. 150 feet to an iron pin; thence S. 36-48 W. 56.15 feet to the point of beginning.
