"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Creenville, on the southern side of Amy Lane, being shown as Lot No. 223 on a plat of Section 6 of Colonial Hills Subdivision, dated March 21, 1963, prepared by Piedmont Engineers and Architects, recorded in Plat Book kWW at Page 12 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Amy Lane at the joint front corner of Lots no. 223 and no. 224, and running thence with the line of lot no. 224 S. 11-40 E. 189.1 feet to an iron pin at the joint rear corner of Lots no. 223 and no. 224; thence with the rear line of Lot No. 245 and no. 246 S. 73-31 W. 100.35 feet to an iron pin at the joint rear corner of tots no. 222 and no. 223; thence with lot no. 222 N. 11-40 W. 197.5 feet to an iron pin on Amy Lane; thence with said Lane N. 78-20 E. 100 feet to the point of beginning.
