WILLIAM F. WISE

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-Two Thousand Eight Hundred and no/100 DOLLARS (\$ 32,800.00---), with interest thereon at the rate of percent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Terramont Circle, being shown as Lot 7 on plat of Terra Pines Estate recorded in Plat Book PPP at pages 18 and 19, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the southeastern side of Terramont Circle at the joint front corner of Lots 6 and 7 and running thence with Lot 6, S 59-04 W 200.9 feet to an iron pin; thence N 35-20 W 255 feet to an iron pin at rear corner of Lot 8; thence with line of Lot 8, N 78-20 E 265 feet to an iron pin on Terramont Circle; thence with the curve of said circle, S 18-02 E 80 feet; thence continuing S 23 E 89.5 feet to the beginning corner.
