SEND GREETING:

Whereas, We, the said Bennie H. Bradberry and Lillian H. Bradberry  
in and by our certain pronsitory note in writing, of even date with these

to be paid Fifteen Dollars (\$15.00) per month

at the rate of 6 per centum per annum, to be computed and paid monthly

with interest thereon from date until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
