WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN
ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of
Thirty One Thousand and No/100ths-----DOLLARS

(\$ 31,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said

fore the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bar-
gained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its
successors and assigns,

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon,
situate, lying and being in the State of South Carolina, County of Greenville, as shown on a plat of
property of Ethel C. Durham to be recorded herewith, by Jones Engineering
Service, dated June 13, 1972, a metes and bounds description being as
follows:

Beginning at an iron pin in the center of the Frady Road, located 158 feet
from the intersection of the old Saluda Dam Road and Frady Road; thence
with the center of the Frady Road, N. 79-39 W. 300 feet to an iron pin,
thence S. 85-23 E. 50 feet to an iron pin; thence S. 10-37 W. 255 feet to
an iron pin; thence S. 14-22 E. 1143.2 feet to an iron pin located 10 feet
from the poinsett branch; thence with the branch being the line the courses
and distances of which are as follows: S. 81-00 W. 129.8 feet to an iron
pin; thence S. 79-07 W. 180.2 feet to an iron pin; thence leaving said
branch and running N. 13-00 W. 699.5 feet to an iron pin; thence N. 3-00
E. 151 feet to an iron pin; thence N. 19-00 W. 208.6 feet to an iron pin;
thence N. 12-00 W. 274 feet to an iron pin; thence N. 1-56 W. 65 feet to
an iron pin located at the beginning point.
