"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, lying on the western side of Lynnurst Drive near the City of Greenville, teing known and designated as Lot No. 189 on a plat of Cak-Crest, Section 2, prepared by C. C. Jones, dated January, 1955, revised August 1955, and recorded in Plat Book GG at Page 130-131 and according to said plat being more particularly described as follows:
