(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Thousand and no/100ths ----- DOLLARS

(\$ 30,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, on the northeastern side of Mustang Circle, being shown and designated as Lot No. 23 on a plat of S. I. RANCHETTES, SECTION 1, made by Dalton and Neves, Engineers, dated April, 1965, recorded in the RMC Office for Greenville County, S. C., in Plat Book JJJ, page 31, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Mustang Circle at the joint front corners of Lots Nos. 22 and 23 and running thence along the common line of said lots N. 47-15 W., 377 feet to a point in or near Gilbers Creek; thence with Gilbers Creek as the line, the traverse line being S. 54-43 W., 96 feet to an iron pin; thence continuing with said creek as the line, the traverse line being S. 39-40 W., 112.9 feet to an iron pin at the joint rear corners of Lots Nos. 23 and 24; thence with the common line of said lots S. 30-22 E., 369.5 feet to an iron pin on Mustang Circle; thence with the curve of Mustang Circle along the northeasterly side thereof, N. 54-08 E., 125 feet to an iron pin; thence continuing with the curve of said Circle, the chord of which is N. 46-16 E., 125 feet to an iron pin, the beginning corner.
