"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, situate on the southern side of a county road and having according to plat of the property of J. R. Moore made by C. O. Riddle August 20, 1957, the following metes and bounds, to-wit:
