TO ALL WHOM THESE PRESENTS MAY CONCERN:

Threatt-Maxwell Enterprises, Inc. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-six and no/100-----DOLLARS

(\$ 26,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 11 on Plat of Eastgate Village made by Piedmont Engineers & Architects, May 15, 1973 and recorded in the RMC office of Greenville County in Plat Book 4X at Page 31. According to said plat the property is more fully described as follows:

BEGINNING at an iron pin on Chesapeake Court at the joint front corner of Lot Nos. 10 and 11 and running thence with the joint line of said lots S. 31-07 E. 85.0 feet to an iron pin in the line of Lot No. 9; thence with line of Lots Nos. 9 and 8 S. 60-03 W. 97.0 feet to an iron pin at the joint corners of Lots Nos. 11, 8, 7 and 12; thence with line of Lot No. 12 N. 25-14 W. 83.5 feet to an iron pin on Chesapeake Court; thence with said court N. 58-53 E. 88.4 feet to an iron pin, the point of beginning.
