The Mortgagor further covenants and agrees as follows:

(1) That the mortgage shall secure the Mortgage for such further sums as may be advanced hereunder at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the requirements herein. This mortgage shall also secure the Mortgage for any further taxes, charges, rentals or expenses that may be imposed upon the Mortgagor by the Mortgagee so long as the total indebtedness does not exceed the original amount of the note herein. All sums so advanced shall bear interest at the same rate as the mortgaged debt and shall be paid in addition of the Mortgagor's debt as herein provided in writing.

(2) That it is agreed that all taxes, assessments, and other charges levied on the mortgaged property is used as may be required from time to time by the Mortgagor to pay the same and no other burdens specified in the Mortgage in an amount not less than the mortgage debt, or interest accrued thereon, plus five percent (5%) thereof. Mortgagor agrees to state in his account statement that all such payments and renewals thereof shall be paid to the Mortgagee. The above fact is acknowledged by the Mortgagor and the Mortgagee, and that it shall pay to the Mortgagee all amounts due thereon, including interest, and that the same shall be paid to the Mortgagee by the Mortgagor directly to the extent of the balance owing on the Mortgage debt.

(3) That it is agreed that the Mortgagor shall pay all taxes, assessments, and other charges levied on the mortgaged property in the amount of \$100.00 per year, and that the same shall be paid to the Mortgagee at its option, either upon and whenever the same become due, or in advance, or quarterly, or semi-annually, or annually, or at such other times as the Mortgagee may require, and charge the expenses for such regular or otherwise periodic payment to the Mortgagor's debt.
