WILLIAM HILLER (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifty Seven Thousand Six Hundred and No/100-----DOLLARS

(\$ 57, 600. 00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Long Point Way, in Austin Township, being shown and designated as Lot No. 58, on a plat of HOLLY TREE PLANTATION, PHASE I., made by Enwright Associates, Inc., dated May 28, 1973, recorded in the RMC Office for Greenville County, S. C., in Plat Book 4-X, page 36, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Long Point Way joint front corner of of Lots Nos. 58 and 59 and running thence with joint line of said lots S. 79-43-00 E. 255 feet to a point in the center of Gilders Creek at the joint rear corner of Lots 58 and 59, and running thence with Gilders Creek as the line, the traverse line of which is S. 36-02 W. 107.14 feet to the joint rear corner of Lots Nos. 57 and 58, thence with the joint line of said lots N. 70-16 W. 178.91 feet to an iron pin on the curvature of Long Point Way, running thence with the curvature of Long Point Way to an iron pin, thence with the eastern side of Long Point Way N. 3-45 E. 30 feet to the point of beginning.

This being the same property conveyed unto the Mortgagor herein by deed from Holly Tree Plantation of even date, to be recorded herewith.
