

WHEREAS, the Mortgagor is well and arrivy indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagoe) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Tvelve Thousand Five Bundred and No/100- - - -

DOLLARS (\$ 12,500.00 ), with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Holmes Drive, in the City of Greenville, known and designated as lot \$87, on a plat of the property of Central Development Corporation, prepared by Dalton & Neves in October 1951, and recorded in Flat Book BB at Pages 22 and 23, and described as follows:

\*BEGINNING at an iron pin on the Western side of Holmes Drive, at the front corner of lots 86 and 87, and running thence N. 61-22 W. 159 feet to an iron pin in line of lot #85; thence with line of said lot, S. 11-45 W. 92.4 feet to an iron pin at rear corner of lot #88; thence with the line of said lot, S. 66-53 E. 136 feet to an iron pin on the Western side of Holmes Drive; thence with the Western side of said Drive, N. 26-28 E. 75 feet to the point of beginning.\*
