All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville. in Paris Mountain Township, situate at the Southwestern corner of the intersection of Tucson Drive and El Paso Drive, and being shown as Lot 28 on a plat of Western Hills, recorded in Plat Book QQ at pages 98 and 99, and having according to said plat the following metes and bounds:
