All that piece, parcel or lot of land lying and being at the westerly corner  
of Reid School Road and U.S. Highway No. 29, near the town of Taylors,  
Greenville County, S.C. and being described from a plat of the property of  
H.R. Stephenson made by Dalton & Neves, dated February, 1956, the following  
metes and bounds, to-wit:

BEGINNING at an iron pin in Reid School Road near its intersection with the  
northwesterly edge of the right-of-way of U.S. Highway No. 29, and running  
thence S 25-17 E 10 feet to a point on the edge of said right-of-way; thence  
turning and following the edge of the right-of-way of U.S. Highway No. 29  
the following courses and distances: S53-15 W 258 feet more or less, N 36-  
45 W 25 feet, S 53-15 W 498 feet more or less, S 36-45 E 25 feet, S 53-15 W  
425 feet more or less; thence turning and leaving said right-of-way S 78-00W  
380 feet more or less to an old iron pin, corner or property now or formerly
