(hereinafter referred to as Mortgagor) SEND(S) GREETING: 820

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Thousand Eight Hundred and No/100 DOLLARS (\$ 20,800.00), with interest thereon at the rate of seven & one-half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Dellwood Drive, in the City of Greenville, S. C., being known and designated as Lot 163 and a portion of Lot 162 on plat of property of Central Development Corp. as recorded in the RMC Office for Greenville County, S. C., in Plat Book BB, pages 22 and 23 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Dellwood Drive, said pin being the northwesterly corner of Lot herein conveyed and the northeasterly corner of Lot 164 and running thence with the southerly side of Dellwood Drive N 81-15 E 75 feet to an iron pin; thence N 73-45 E 25 feet to an iron pin; thence leaving Dellwood Drive S 16-36 E 188.9 feet to an iron pin; thence S 63-51 W 39.5 feet to an iron pin; thence N 81-53 W 107.8 feet to an iron pin; thence N 3-22 W 165 feet to an iron pin, the point of beginning.
