(hereinafter referred to as Mortgagor) SEND(S) GREETING(S)

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-One Thousand and no/100-----

DOLLARS (\$21,000.00-----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Paris Mountain Township, Greenville County, South Carolina, being known and designated as Lot No. 7 on Plat of a Subdivision known as San Souci Heights No. 1, which plat is recorded in the RMC Office for Greenville County in Plat Book 1H at Page 25 and having, according to said plat, the following metes and bounds, to-wit:
