WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the southern side of Trafalgar Road and being known and designated as Lot No. 127 on a plat entitled "NORTHWOOD HILLS, Section III" recorded in the RMC Office for Greenville County in Plat Book YY at Page 37 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Trafalgar Road, joint front corner To Lots 126 and 127 and running thence along cormon line of said Lots, S.09-13 E. T/9.3 feet to an iron pin in the rear line of Lot 115; thence along the rear line of Lot 115, N.87-10 E. 110 feet to an iron pin, joint corner of Lots 79, 80, 115 and 127; thence along common line of Lots 80 and 127, N.Ol-11 W. 180.3 feet to an iroz pin on the southern side of Trafalgar Road; thence along said Road, S.87-13 W. 135 feet to an iron pin, the point of beginning.
