NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Boulder Road, being shown and designated as Lot 30 on a Plat of Forrester Woods, recorded in the RMC Office for Greenville County in Plat Book 4-N, at Page 78, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the western side of Boulder Road, joint front corner of Lots 29 and 39, and running thence with the common line of said Lots, N 62-24 W, 160 feet to an iron pin; thence along the common line of Lots 30 and 31, N 27-36 E, 110 feet to an iron pin; thence along the common line of Lots 30 and 33, S 62-24 E, 160 feet to an iron pin on Boulder Road; thence with said Road, S 27-36 W, 110 feet to an iron pin, the point of beginning.
