That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Templewood Drive, being known and designated as the major portion of Lot No. 52, of Section I, of OAK CREST, on a plat thereof made by C. C. Jones & Associates dated January 1955, revised August 1955, recorded in the R. M. C. Office for Greenville Country, S. C. in Plat Book GG, pages 130 and 131, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Templewood Drive at the joint front corners of Lots Nos. 52 and 53, Section I, and running thence along the common line of said lot, S. 29-50 E., 150 feet to a point; thence along the rear lines of Lots Nos. 58 and 59, N. 60-02 E., 70 feet to a new point (said new point being 5 feet southwest from the joint rear corners of Lots Nos. 51 and 52); thence a new line through Lot No. 52, N. 29-58 W., 150 feet to a point on the southeastern side
