TO ALL WHOM THESE PRESENTS MAY CONCERN: Fletcher J. Hawkins & Gaynell B. Hawkins

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-four Thousand ----- DOLLARS (\$ 24,000.00), with interest thereon at the rate of six & one-half per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, on the northwest side of Dameron Avenue, being shown as Lot No. 40 on Plat of Section F of Gower Estates, recorded in the RMC Office for Greenville County, S. C., in Plat Book JJJ, page 99, made by R. K. Campbell and Webb Surveying & Mapping Co., November 1965, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwest side of Dameron Avenue at the joint front corner of Lots 39 and 40 and runs thence along the line of lot 39, N. 21-20 W. 180 feet to an iron pin; thence S. 70-08 W. 152 feet to an iron pin; thence along the line of Lot 41 S. 19-28 E. 186.9 feet to an iron pin on the northwest side of Dameron Avenue; thence along Dameron Avenue N. 71-58 E. 140.4 feet to an iron pin; thence still along Dameron Avenue N. 65-58 E. 20 feet to the beginning corner.
