
REAL PROPERTY AGREEMENT

The affidavit of any officer or department manager of Association aboving any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
