), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said (\$25,000.00 note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Rutherford Road (also known as S. C. Highway 21), being shown and designated as Lot 5 and the eastern one-half  $(\frac{1}{2})$  of Lot 4 on a plat of Croft Stone Acres, made by W. D. Neves Engineers, March, 1917, said plat being recorded in the RMC Office for Greenville County in Plat Book E at Pages 35 & 36, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Rutherford Road, joint corner of Lots 5 & 6, said pin being 250 feet west from the northwestern corner of the intersection of Rutherford Road and an unhamed street and running thence with the northern side of Rutherford Road S. 73-25 W. 299.5 feet to an iron pipe, said pipe being 569.5 feet east from the northeastern corner of the intersection of Rutherford Road and Wedgewood Avenue; thence N. 11-55 W. 252 feet to an iron pipe; thence N.67-30E. 97.5 feet to an iron pipe; thence N. 73-50 E. 224.6 feet to an iron pipe; thence S. 7-20 E. 263 feet to an iron pipe on the northern side of Rutherford Road, the beginning corner.
