MORTGAGE

THIS MORTGAGE is made this 31st day of August 1979, between the Mortgagor, DAVIDSON VAUGHT, A GENERAL PARTNERSHIP (herein "Borrower"), and the Mortgagee, FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of South Carolina, U.S.A., whose address is P. O. Box 10148, Greenville, South Carolina (herein "Lender").

WHEREAS Borrower is indebted to Lender in the principal sum of Thirty-Nine Thousand Six Hundred & No/100 Dollars, which indebtedness is evidenced by Borrower's note dated August 31, 1979 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on July 1, 2005

O. Riddle, recorded in the RMC Office for Greenville County in Plat Book 6-H, Page 47, reference to which is hereby made for a metes and bounds description thereof.
