NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Ardmore Drive and being known and designated as Lot No. 147 of COLONIAL HILLS Subdivision as shown on plat recorded in the RMC Office for Greenville County in Plat Book BBB at Page 91 and also shown on a more recent plat entitled "Property of Richard N. Gable and Barbara S. Gable", dated October 23, 1975, prepared by W. R. Williams, Jr., and having, according to the more recent plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Ardmore Drive at the joint front corner of Lots Nos. 147 and 148 and running thence with the line of said Lots, S.11-17 E. 173.9 feet to an old iron pin; thence S.78-16 W.90 feet to an iron pin at the joint rear corner of Lots Nos. 146 and 147; thence with the joint line of said Lots, N.11-41 W. 169.3 feet to an iron pin on the southern side of Ardmore Drive; thence with the southern side of said Drive, N.75-20 E. 90 feet to the point of beginning.

THIS is the same property as that conveyed to the Mortgagors herein by deed from Richard N. Gable and Barbara S. Gable recorded in the RMC Office for Greenville County on April 21, 1978.
