to an iron pin; thence N. 24-00 W. 114.0 feet to an iron pin in the
line of property now or formerly of Greenville Municipal Airport;
thence with the line of property now or formerly of Greenville
Municipal Airport, N. 46-00 W. 22.3 feet to an iron pin in the line
of property now or formerly of Seaboard Coast Line Railroad Company;
thence with the line of property now or formerly of Seaboard Coast
Line Railroad Company, S. 24-00 E. 114.0 feet to an iron pin; thence
continuing with the line of property now or formerly of Seaboard
Coast Line Railroad Company, S. 24-00 E. 272.9 feet to an iron pin
at the joint corner of the premises herein described and property
now or formerly of Ramsey Fuel Oil Company; thence with the line of
property now or formerly of Ramsey Fuel Oil Company, N. 66-00 E.
200.0 feet to the point of beginning.

attached, connected, or fixed thereto in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than the
usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is
lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided
herein. The Mortgagee further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and
against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
