(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagee's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Twelve Thousand and No/100
DOLLARS (\$ 12,000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of Eighty-Seven and No/100--- Dollars (\$ 87.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagee may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the Southwestern corner of Woodridge Drive and Parkdale Drive, near the City of Greenville, being shown as Lot No. 58 on Plat of Parkdale Subdivision recorded in Plat Book 3R, at page 55, and described as follows:

BEGINNING at an iron pin at the Southwestern corner of Parkdale Drive and Woodridge Drive, and running thence with the Western side of Woodridge Drive, S. 3-22 E. 95 feet to an iron pin at corner of Lot No. 57; thence with the line of said lot, S. 86-38 W. 160 feet to an iron pin in line of Lot No. 59; thence with the line of said lot, N. 3-22 W. 85 feet to an iron pin on Parkdale Drive; thence with the Southern side of said Drive, N. 74-31 E. 138.7 feet to an iron pin at the corner of Woodridge Drive; thence with the curve of the intersection, the chord of which is S. 54-26 E. 31.3 feet to the beginning corner.
