WITNESSETH THAT, WHEREAS, Mortgagor is indebted to Mortgagee for money loaned for which Mortgagor has executed and delivered to Mortgagee a Note of even date herewith in the principal sum of SEVEN THOUSAND AND NO/100----- (\$ 7,000.00), the final payment of which is due on November 15 1981, together with interest thereon as provided in said Note, the complete provisions whereof are incorporated herein by reference;

AND WHEREAS, to induce the making of said loan, Mortgagor has agreed to secure said debt and interest thereon (together with any future advances) and to secure the performance of the undertakings prescribed in the Note and this Mortgage by the conveyance of the premises hereinafter described:


NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville County, South Carolina:

All that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 296, Section V, Sheet 1, of Subdivision known as JOINTMA, said Subdivision being situated within the corporate limits of the Town of Simpsonville, plat of said Subdivision being recorded in the FMC Office for Greenville County in Plat Book 4-R, Page 87, and having according to said plat the following notes and bounds, to-wit:

Beginning at an iron pin on the northern side of Oglewood Drive at the joint front corner of lots 295 and 296 and running thence along the common line of said lots N. 42-35 W. 175.0 feet to an iron pin; thence along the common line of lots 296 and 293 N. 42-29 E. 122.0 feet to an iron pin; thence along the common line of lots 296 and 297 S. 48-29 E. 174.53 feet to an iron pin on the northern side of Oglewood Drive; thence along the said Oglewood Drive S. 42-33 W. 140.0 feet to an iron pin, the point of beginning.
