Timothy Alan Ridgeway and Sandra / (hereinafter referred to as Mortgagors) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

ALL that certain piece, parcel or lot of land situate, lying and being on the southeastern side of Dividelle Drive near the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 30, Section IV of a Subdivision known as Richmond Hills, plat of which is recorded in the GMC Office for Greenville County, South Carolina in Plat Book JJJ at page 81 and according to said plat, having the following metes and bounds, to wit:
