
MORTGAGE DEED

KNOW ALL MEN BY THESE PRESENTS that AMERICAN MONORAIL, INC., an Ohio corporation, the Grantor (which term wherever appearing herein shall be taken for convenience as referring to the undersigned, whether a person, persons, partnership or corporation, and, where the context so admits, to the heirs, executors, administrators, successors and assigns of the undersigned, as the case may be), for the consideration of the extension of credit by Grantee (as hereinafter defined) to Grantor under outstanding irrevocable letters of credit in the aggregate amount of Two Hundred Eighty Thousand Five Hundred Dollars (\$280,500) and for the consideration of Nine Hundred Fifty Thousand Dollars (\$950,000) loaned to Fisher Industries, Inc., an affiliate of Grantor, on a demand basis in partial reliance on the continuing guarantee of the Grantor, and for the consideration of all indebtedness at any time outstanding under the above-described letters of credit, and for all other extensions of credit to the Grantor or to Fisher Industries, Inc. (all such extensions of credit to the Grantor and the Grantor's obligations under the above described continuing guarantee hereinafter referred to as "Obligations") by
