All that certain piece, place or lot of land, with all improvements thereon, or hereafter constructed thereon,
situate, lying and being in the State of South Carolina, County of Greenville, on the southern side
of Pinewood Drive and being shown as all of lot 134 and the eastern one-half of
lot 135 in plan of Oak-Crest, recorded in Plat Book 22 at Pages 130 and 131 and
when described as a whole has the following lines and bounds, to-wit:

1935-1936 at an iron pin on the southern side of Greenwood Drive the joint front corner of Lots 133 and 134 and running thence with the line of Lot 133 S. 27-12 E. 150 feet to an iron pin; thence N. 60-15 E. 115 feet to an iron pin S. 27-12 E. 150 feet to an iron pin; thence through center of Lot 135 N. 27-12 E. 150 feet to an iron pin on Greenwood Drive, said pin being in the center of the front line of Lot 135; thence with the southern side of Greenwood Drive S. 60-15 E. 115 feet to the point of beginning."
