THIS MORTGAGE is made this --30th-- day of JULY, 1979,

between the Mortgagor, GEORGE O'SHIELDS BUILDERS, INC., (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of THIRTY-SEVEN THOUSAND SIX HUNDRED AND 00/100 Dollars, which indebtedness is evidenced by Borrower's note dated JULY 30, 1979 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on JULY 1, 2010.

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Town of Simpsonville, being shown and designated as lot no. 179 on plat of Brentwood, Section IV, as recorded in the RNC Office for Greenville County in Plat Book 50 at page 43, and a more recent plat of Property of George O'Shields Builders, Inc., dated July 26, 1979, prepared by Freeland and Associates, and having, according to the more recent plat, the following metes and bounds, so-wit:

BEGINNING at an iron pin on the northern side of Brentwood Way, joint from corner with lot 191 and running thence N. 1-36 E., 120.4 feet to an iron pin; thence turning and running along the rear line of lot no. 179, N. 89-39 E., 150.0 feet to an iron pin; thence turning and running along the common line of lots 179 and 178, S. 1-35 E., 121.10 feet to an iron pin on Brentwood Way; thence with said Brentwood Way, S. 89-57 W., 150.0 feet to an iron pin, being the point of beginning.
